I am aware of and agree to be bound by the General Regulations of the Society and those governing Livestock Exhibitors. 3. I understand that the Society's Public Liability Insurance Policy does not cover exhibitors or their animals and it is in my interests, therefore, to obtain my own Public Liability Insurance cover for the Show period.
